

Official Rules

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

1. **ELIGIBILITY:** The Galentine's Giveaway ("Sweepstakes") is sponsored by Arena Operating Company, Ltd. ("Sponsor"). The Sweepstakes is open to all legal residents of Florida who are 18 years old or older ("Eligible Person"). Employees and officers of Sponsor and Sponsor's parent companies, subsidiaries, affiliates and related entities, advertising agencies, authorized dealers, promotional suppliers, prize providers (each of the aforementioned entities collectively, with Sponsor, the "Sweepstakes Entities") and the immediate family members (spouses, parents, children and siblings and their spouses) or members of the same household (whether related or not) of such individuals are not eligible to enter or win. Void where prohibited.
2. **HOW TO ENTER:** Each Eligible Person is limited to (1) entry and may enter only by (i) using an Instagram account (the "Account") to "like" the post to be distributed to promote the Sweepstakes on the official Amerant Bank Arena Instagram account (@amerantbankarena) (such post, the "Post"), (ii) using the same Account to "follow" the official Amerant Bank Arena Instagram account (@amerantbankarena), and (iii) using the same Account to share the Post as an Instagram story on such Account. However, one (1) additional entry per Eligible Person will be accepted when the Account tags another account on the Post.

The Sweepstakes shall commence on February 11, 2026, and the deadline for the Amerant Bank Arena Marketing Department to receive all entries for the Sweepstakes is February 18, 2026, at 11:59PM Eastern Standard Time ("Sweepstakes Time Period"). No entries will be accepted after such time.

3. **ODDS OF WINNER SELECTION AND PRIZE:** Following the conclusion of the Sweepstakes Time Period, Sponsor shall select one (1) Eligible Person ("Winner") from a random drawing of all eligible entries received during the Sweepstakes Time Period to receive four (4) tickets for seats to be determined by Sponsor in its sole discretion to the Boys 4 Life Tour featuring B2K & Bow Wow show to take place at the sports and entertainment facility currently known as Amerant Bank Arena on April 11, 2026 ("Prize"). The fair market value of the Prize is \$707.00 USD. Odds of winning depend on the number of eligible entries received during the Sweepstakes Time Period.
4. **WINNER NOTIFICATION:** Winner shall be contacted on or after February 19, 2026 by the @amerantbankarena Instagram account via direct message and will be tagged in the comment section of the Post. Instructions for receiving the Prize will be sent to the Winner via the Instagram account supplied on entry. Each entrant is responsible for monitoring his/her Instagram account for prize notification and receipt or other communications related to this Sweepstakes. If Winner cannot be reached by the Sponsor within (1) day or if the Prize is returned as undeliverable, Winner may be considered to have forfeited the Prize, and the Prize may be awarded to an alternate

winner, who will be selected from a random drawing of all remaining eligible entries. Upon the request of the Sponsor, Winner may be required to return an Affidavit of Eligibility, Release and Prize Acceptance

Form, IRS W-9 form, a liability release, and (where legal) a publicity release, all of which must be returned within the time period specified within such materials. Should the potential winner fail to comply with any such requirements, that potential winner may be disqualified by Sponsor, in Sponsor's sole discretion, and Sponsor may then select an alternate winner.

Any portion of Prize not accepted by Winner will be awarded to a substitute winner in accordance with Section 4 above. In no event will Sponsor be liable to award more than the number of prizes stated in these Official Rules.

6. **ACCEPTABLE CONDUCT:** By entering this Sweepstakes, entrants agree to be bound by these Official Rules and the decisions of the Sponsor, which shall be final and binding in all respects. Failure to comply with these Official Rules may result in disqualification. Sponsor reserves the right at its sole discretion to disqualify any individual suspected of tampering with the entry process or the operation of the Sweepstakes; or to be acting in any manner deemed by Sponsor to be in violation of the Official Rules; or to be acting in any manner deemed by Sponsor to be unsportsmanlike or disruptive, or with intent to annoy, abuse, threaten or harass any other person. 7. **LIMITATIONS OF LIABILITY:** The Sponsor assumes no responsibility or liability for (a) any incorrect or inaccurate registration or entry information, or for any faulty, failed, garbled or jumbled electronic data transmissions; (b) any unauthorized access to, or theft, destruction or alteration of entries at any point in the operation of this Sweepstakes; (c) any technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation or communications line failure,

regardless of cause, with regard to any equipment, systems, networks, lines, satellites, servers, computers or providers utilized in any aspect of the operation of the Sweepstakes; (d) inaccessibility or unavailability of the Internet, the Application (if applicable), or any combination thereof; or (e) any injury or damage to participant's or to any other person's computer or cell phone which may be related to or resulting from any attempt to participate in the Sweepstakes or download any materials in the Sweepstakes. If, for any reason, the Sweepstakes is not capable of running as planned for reasons which may include without limitation, infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes which may corrupt or affect the administration, security, fairness, integrity or proper conduct of this Sweepstakes, then Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the Sweepstakes in whole or in part.
